**Proposal:** Conversion of existing outbuilding into ancillary living accommodation including the addition of a rear dormer and balcony, and extended roof over existing tore/washroom **Location:** Inglewood Lancaster Road Knott End-on-Sea Poulton-Le-Fylde Lancashire

No objection – a concern was raised that may be too extensive for the site (3 in favour, 1 against, 1 abstention).

#### Application Number: 21/01241/FUL

**Proposal:** Side and rear extension **Location**: Penview Rosslyn Avenue Preesall Lancashire FY6 0HE

Objected - The proposed build overshadows the neighbouring property, potentially causing a loss of light. (1 in favour, 3 against, 1 abstention).

#### Application Number: 21/01250/FUL

**Proposal:** Change of use of land from agricultural to domestic, erection of single-storey building consisting of garage, workshop and stabling (following demolition of existing agricultural buildings) (resubmission of 20/00786/FUL) **Location:** Braemar Rosslyn Avenue Preesall Lancashire FY6 0HE

No objection – Grounds given for objection (change of use of land) not valid in these circumstances (2 in favour, 2 against, 1 abstention).

**Proposal**: Proposed roof lift, front and rear dormers and rear balcony to existing annexe. Location: 6 Little Tongues Lane Preesall Poulton-Le-Fylde Lancashire FY6 0PD

No objection - (4 in favour, 1 abstention)

**Proposal**: Single-storey rear extension, roof lift and two rear dormers **Location**: Mallards 19 Pilling Lane Preesall Poulton-Le-Fylde Lancashire

## 8 Flag flying

i) Cllr Orme would like to ask councillors to consider the arrangements for flying the Union flag as it is now possible for it to be flown all year round. The council doesn't have a building - the nearest equivalent is the cenotaph flagpole. Councillors are asked **to support** the notion of flying the Union flag at the cenotaph at all times unless it's St George's Day or Armed Forces Day etc.

## 10 Victorian verandas

Cllr Drobny wishes to discuss the possibility of making improvements to the shopping experience in the village with the purchase of Victorian veranda shopfront covers. This follows disturbances on Beechfield Avenue, with children from Willows Close congregating, riding motorised scooters and verbally abusing residents.
