I refer to the above details. An appeal has been made to the Secretary of State against the decision made by Wyre Council.

The appeal will be determined on the basis of an **Informal Hearing**. The procedure to be followed is set out in Town and Country Planning (Appeals) (Hearings Procedure) (England) Rules 2000 (as amended).

The hearing will take place at the Civic Centre, Breck Road, Poulton-Le-Fylde, where there is disabled access points from both front and side entrances, together with designated disabled parking spaces. The hearing will commence at **10 a.m. on Tuesday 30th August 2022** and is scheduled to last for **two** days. (Please note this may be subject to change)

All of your comments have been passed to the Planning Inspectorate.

6 Reports from committees and working groups

i) Finance committee

Councillors are asked **to note** that the committee will meet at 6.45pm, prior to full council. A brief verbal update will be provided by the chair.

ii) Civic Events committee

Councillors are asked **to note** that the committee met at 6.30pm on 20 June. A brief verbal update will be provided by the chair and Cllr Johnson will put forward a proposal to hold the event at a future date.

7 Blue plaques

Cllr Drobny would like to ask councillors to agree to the purchase of 10 blue plaques to be sited at various landmarks within the community to mark the history of Preesall and Knott End-on-Sea. Details of the plaques and costings will be brought to the meeting.

8 Footpath from Cemetery Lane

Cllr Drobny would like to ask councillors to consider the possibility of creating a footpath from the corner of Cemetery Lane and Burned House Lane to Shirley's Pies. As this is a very dangerous road a pathway would help provide safe pedestrian access without the need to walk on a busy A classified road. There is a possibility of land being granted free of charge should the council wish to pursue this.

9 Lengthskeeper's workshop and council storage

Cllr Shepherd would like to ask councillors to put forward any ideas for premises that may be suitable for storage of council property and provide a suitable building from which the lengthskeeper can work. Currently the majority of the council's property is held by the clerk

and the lengthskeeper is without a workshop area. Councillors are asked to determine the course of action to be taken to provide a resolution to the problems.

10 Disposal of green waste

Cllr Tarpey-Black would like to ask councillors to consider making suitable arrangements for the disposal of green waste collected by the lengthskeeper. Over the winter months it isn't a great problem, however, over the summer months the amount of waste collected and needing storage can be excessive. Councillors are asked to decide a suitable course of action.

11 Consultations

i) Pharmaceutical Needs Assessment 2022

The Pharmaceutical Needs Assessment (PNA) is a comprehensive assessment of the current and future pharmaceutical needs of the local population.

Blackburn with Darwen, Blackpool and Lancashire health and wellbeing boards have a statutory duty to publish a PNA every three years, under the NHS (Pharmaceutical Services and Local Pharmaceutical Services) Regulations 2013. The last assessment was published in March 2018 and a revised assessment must be published by October 2022.

The PNA describes the current provision of pharmaceutical services across the pan-Lancashire footprint and whether this meets the current and future needs of the area.

PNAs are used by NHS England to inform decisions regarding applications for new or changes to existing pharmaceutical services and to make decisions in the commissioning of additional services from pharmacy.

The consultation will take place from Friday 1 July 2022 to Thursday 1 September 2022.

All findings and comments will be summarised for the final PNA document. A consultation report will be included within the final PNA document. This will provide an overview of the feedback received and set out how the comments have been acted upon.

The consultation is open to businesses, the general public and public authorities. The council has been invited to respond by the Lancashire Health and Wellbeing Board. Councillors are asked **to determine** how they wish to proceed.

ii) Youth anti-social behaviour task group survey

The overview and scrutiny committee at Wyre Council has recently commissioned a task group for councillors to review how the council tackles youth anti-social behaviour and identify areas for improvement.

The task group would love to hear from parish/town councils in Wyre about their experience with youth anti-social behaviour. The town council's views will provide the group with a greater perspective of this topic on a local level and assist them to make meaningful recommendations to Wyre's Cabinet to improve and support the council to tackle the problem.

The group has created a survey and would be very grateful if the town council would fill it out. A copy has been **emailed** for councillors to discuss at the meeting.

12 Training

A list of NALC training events has been **emailed.** Should any councillor wish to attend an event they should register their interest with the clerk prior to the meeting. Approval will be sought for payment of the fees from the council at the meeting.

13 Purchase of Arnold-Baker on Local Council Administration

This is a complete statement of the law relating to parish and community councils, in the form of an extensive though succinct narrative accompanied by comprehensive statutory materials. The clerk's copy of the 'Yellow Book' is now six years old and needs to be replaced. The latest version – 13th edition is scheduled for release in November and is now available for preorder at a cost of £137.00 plus £4.00 postage. Councillors are asked to approve the purchase of the latest edition.

14 Public Rights of Way Local Delivery Scheme 2022-23

Lancashire County Council is once again offering town and parish councils £500 to take part in the scheme. The scheme does not include stiles but includes vegetation clearance, signposts, waymarks, steps, gates, and assistance from the parish council with proposed developments in its vicinity that could affect a public right of way.

In addition, it is also offering £300 in the form of biodiversity grant. The type of projects the grant can be used for are listed below but the council is free to undertake its own projects with a biodiversity theme. The grant can also be used to encourage community groups/schools etc to participate in the council's projects.

Type of projects include: • nest boxes • bird feeders • bug hotels • hedgehog houses • bat boxes • log piles • communal gardens • pollinator nest sites • planting wildflowers • creating ponds • living walls • rain gardens.

Councillors are asked to determine whether they would like to be involved with the schemes.
