This meeting may be recorded by the council, members of the public or the press.

Prior to the start of the meeting the chair will make an announcement to confirm if anyone present intends to record proceedings.

It is important to note that those intending to record do not have to indicate as such but are required to do this in a way that is not disruptive of the meeting and does not focus on the public gallery.

Members of the public participating in the meeting (e.g. making deputations, asking questions, making oral protests) should be aware that they may be filmed, recorded or reported on. If any member of the public speaking at the meeting does not wish to be recorded, they should let the chair of the meeting know.

"The chair of the meeting has the discretion to terminate or suspend filming or recording, if in their opinion continuation of the filming, recording or reporting would disrupt or prejudice the proceedings, infringe the rights of any individual or may lead to the breach of a legal obligation by the council."

1 Apologies for absence

To receive apologies for absence.

2 Declaration of interests and dispensations

To receive from councillors, disclosures of pecuniary and non-pecuniary interest and dispensation requests on matters to be considered at the meeting.

3 Public Bodies (Admission to Meetings) Act 1960 - Exclusion of the Press and Public

Pursuant to Section 1(2) of the Public Bodies (Admission to Meetings) Act, the Council may resolve to exclude the press and public to discuss the following items:

- i) relating to the resignation of a councillor.
- ii) relating to interview questions - given that interviews have only recently taken place councillors are asked to devise a new set of questions and agree who will ask which question/s. A copy of previous questions has been **emailed**.
- iii) relating to the co-option of a town councillor:

It is anticipated that the press and public will be excluded for the presentations.

This advice has been received from LALC to maintain the possible confidentiality of applicant's personal details.

4 Co-option interviews to fill the current vacancies on the council

5 Public Bodies (Admission to Meetings) Act 1960 - Re-admission of the Press and Public

6 Voting

A vote will be taken either by a show of hands or by signed ballot, whichever is requested by a majority of members.

7 Items for next agenda

The next meeting will be held on **12 December 2022 at 6.15pm** - councillors are asked to raise matters to be included on the agenda and provide updates from working groups by notifying the clerk **in writing by Thursday 3 November 2022** at the latest. The item should specify the business which it is proposed be transacted, in such a way that the members who receive it can identify the matters which they will be expected to discuss i.e. it needs to specify either what the proposal is and that a decision is required or whether the item is for information only.
